An OCCF Signature Fund combines the best features of a private foundation with the ease of a donor-advised fund, affording the utmost in privacy, flexibility, multi-generational family engagement and philanthropic expertise while enjoying the tax benefits associated with a public charity. Funds with assets of \$1M or more are eligible for expanded concierge services including:

- Personalized family philanthropy planning with hands-on engagement of multiple generations
- Development and administration of customized grant programs, including international granting
- Dedicated marketing and web support tailored to your family's visibility preferences
